# GENERAL TERMS AND CONDITIONS OF BUSINESS (GTCB)



1. The GLASI-BONUS SYSTEM is reserved to all customers who have registered personally for this offer from Glasi Hergiswil.

2. The participation in the GLASI-BONUS system is connected to no obligations of any kind.

3. With their personal application customers are automatically entered in the GLASI-BONUS system. Thereby customers give Glasi Hergiswil their permission to collect personal data and information on their purchases and to evaluate and use them for marketing purposes and market research. At each new purchase customers are identified and the purchase is recorded. These data are strictly confidential and are not made available to third parties.

4. Glasi customers can cancel the delivery of product information and/or their participation in the GLASI-BONUS system at any time. A written statement to Glasi is required.

5. At each purchase in our shops or in the Glasi online shop at [www.webshop.glassi.ch](http://www.webshop.glassi.ch), the purchase amount is automatically registered and used as a basis to calculate the bonus.

6. The basis used to calculate the GLASI-BONUS is the net purchase amount. For every CHF 500.– of net purchase amount you receive a bonus of CHF 25.–. Once a year you receive your GLASI shopping voucher, which is valid until December 31st of the following year.

7. The GLASI-BONUS can be redeemed in our shops in Hergiswil or in our Glasi web shop up to the expiry date which is printed on the voucher. The GLASI-BONUS may not be exchanged for cash. It cannot be replaced in case of loss or theft.

8. The GLASI-BONUS is personal and may only be transferred to other persons living in the same household. Partial redemption is not allowed.

9. The GLASI-BONUS system is for the benefit of private individuals only.

10. The GLASI-BONUS may be used exclusively for the purchase of articles made by Hergiswiler Glas AG. Services and gift vouchers are excluded.

11. In case of misuse or violation of these Terms and Conditions, Glasi Hergiswil reserves the right to ban customers from participating in the GLASI-BONUS system without giving any reasons. In these cases Glasi Hergiswil will not include the purchase amounts in the calculation of the GLASI-BONUS.

12. Glasi Hergiswil reserves the right to alter these Terms and Conditions at any time. The valid version is published on the web at [www.webshop.glassi.ch](http://www.webshop.glassi.ch) and is considered accepted by registered customers from the date of publication. Glasi Hergiswil reserves the right to modify the GLASI-BONUS system or to cancel the programme at any time or to suspend the registration of purchase amounts in cases of electronic failure or in circumstances outside its control.

13. The place of contractual fulfilment and court of jurisdiction is Hergiswil. The commercial relationships between customers and Glasi Hergiswil are regulated exclusively by Swiss law.
